| <ol style="list-style-type: none"> 1. Following a score, A-1’s throw-in is deflected out of bounds on the end line by B-1. Official awards the ball out of bounds to team A and rules team A retains the privilege of running the end line. Is the official correct? 2. A-1 and B-1 are bleeding and directed to the bench to be replaced. Team A requests a time-out to keep A-1 in the game. Team B decides to replace B-1. Official grants team A its time-out before B-1 is replaced. Is the official correct? 3. Thrower-in A-1 inbounds the ball to A-2. A-1 following the throw-in delays entering the court. Official charges A-1 with a technical foul. Is the official correct? 4. As the teams come onto the playing court following a time-out the official notices water in front of team A bench. Official has the water wiped up and issues a warning to team A. Is the official correct? 5. A-1 rebounds the ball off of team B’s backboard and passes the ball toward A-2, who moves away from the ball and does not touch it. A-1 picks up the ball before it is touched by anyone and dribbles. Official rules this a legal play. Is the official correct? 6. B-1 reaches through the plane of the boundary line and fouls thrower-in A-1. Official charges B-1 with an intentional personal foul and issues a warning to team B. Is the official correct? 7. A-1’s pass from team A’s backcourt hits a teammate who is in frontcourt. Ball rebounds into the backcourt and is first touched by A-1. Official rules this a legal play because there was no player control in the frontcourt. Is the official correct? 8. A-1 is between B-1 and B-2 on the restraining circle prior to the jump ball. When the official is ready to make the toss, A-1 backs straight off the circle. B-1 moves over next to B-2. Official rules this a legal play. Is the official correct? 9. While A-1 is in the act of shooting, B-2 pushes A-2 into A-1. A-1 continues the motion and scores. Team A is in the bonus. The manner of B-1’s foul was not intentional. Official charges B-2 with a personal foul, counts the basket and awards A-2 a one and one. Is the official correct? 10. While A-1’s try is in flight, official calls a double personal foul. A-1’s try is successful. Official counts the goal and resumes play by awarding the ball to team B. Is the official correct? 11. Jumper A-1 taps the ball which is simultaneously deflected out of bounds by A-2 and B-2. Official has the original jumpers re-jump. Is the official correct? 12. A-1 receives the ball while airborne. A-1 lands on one foot, jumps and lands on both feet simultaneously. A-1 picks up his/her right foot and places it back to the floor before releasing the ball. Official rules this a legal play. Is the official correct? 13. While the official passes team A’s bench, someone from the bench utters uncomplimentary language. The official is not able to designate which bench personnel uttered the words. Official charges a technical foul to the head coach. Is the official correct? 14. A-1 is standing with one foot in the 3 second restricted area and the other foot is outside the area. A-1 lifts the foot from the restricted area and returns it there without touching it first in the non-restricted area. Official terminates the count and starts a new count. Is the official correct? 15. Substitute B-6 enters the court while the ball is in control of team A and while the ball is live and the clock is running. The officials are unaware that team B has 6 players in the game. B-6 returns to the bench after which team A commits a violation. The scorer now informs the officials that team B had 6 players on the court. Official rules no technical foul can be charged. Is the official correct? 16. While A-1 is dribbling, A-2 is charged with a common foul. This is team A’s seventh foul of the half. Official awards team B a one and one. Is the official correct? 17. A-1 receives the ball while both feet are on the floor. A-1 steps forward and to the left with his/her left foot. He/she then lifts his/her right foot and starts a dribble to his/her right in an attempt to go around his/her opponent. Official rules this a legal maneuver. Is the official correct? 18. A-1 is at the line to attempt a free throw when disconcerted by several opponents from the bench. A-1’s try is unsuccessful. Official rules only the players on the floor can disconcert. Is the official correct? 19. Team A is charged with a technical foul. B-6 replaces B-5 to attempt the free throws. Following the attempts, B-2 has the ball for the throw-in when the timer erroneously starts the game clock. Official sounds the whistle and while correcting the time, B-5 reports to replace B-6. Official beckons B-5 in the game. Is the official correct? 20. Prior to A-1 releasing the ball on his/her free throw, B-1 steps into the lane. The official inadvertently sounds the whistle. Official readministers the free throw which is unsuccessful. Official awards A-1 a substitute free throw. Is the official correct? 21. A-1, who is at the free throw line, has the ball and is making preparation for a free throw attempt when A-2 commits a common foul against B-2. Official rules this a team control foul. Is the official correct? 22. A-1 receives the ball while standing in the lane with his/her back toward the basket. A-1 starts to pivot and starts his/her arm movement which will end in a try for goal. As A-1 steps he/she is pushed by B-1. A-1 continues his/her pivot and releases the ball. Ball enters basket. Official rules continuous motion, counts the goal and awards A-1 one free throw. | 23. | Yes | No | 23. After the 15 second warning signal sounds prior to ending the half time intermission, substitute A-6 is enroute to the scorer's table to report. A-6 reports 5 seconds before the signal sounds signifying the end of the intermission. Official allows A-6 to enter the game. Is the official correct? |
| 24. | Yes | No | 24. In the second quarter team A is issued a warning for delaying the game by huddling in the lane prior to a free throw. In the third quarter, A-1 violates by breaking the plane of the boundary line. Official assesses team A with a technical foul. Is the official correct? |
| 25. | Yes | No | 25. During a throw-in by A-1, A-2, A-3 and A-4 line-up shoulder to shoulder and parallel to the end line and within 3 feet of it. Captain of team B requests space between each of the team A players. Official denies the request. Is the official correct? |
| 26. | Yes | No | 26. Prior to the game a technical foul is charged to team A. While the ball is at the disposal of B-1 for his/her first free throw a double personal foul is assessed. Official readministers the first free throw and following the second free throw, awards team B the ball for a throw-in at the division line and sets the arrow toward team A's basket. Is the official correct? |
| 27. | Yes | No | 27. A-1 commits his/her fifth foul. Team A has no substitutes available to replace A-1. Coach wants to use the 20 seconds allowable to replace a disqualified player. Official rules the 20 seconds may not be used and play will resume immediately. Is the official correct? |
| 28. | Yes | No | 28. While team A is in control, A-1 and B-1 begin to fight. A-6 and B-6 enter the court but do not participate in the fight. Official ejects A-1, B-1, A-6 and B-6 and banishes them to the bench. Official charges each coach with one indirect technical foul, team A and team B with two team fouls and resumes play at the point of interruption. Is the official correct? |
| 29. | Yes | No | 29. A-1 enters the game wearing a sweatband that is 6 inches wide. Official rules A-1 must remove the sweatband before he/she can participate. Is the official correct? |
| 30. | Yes | No | 30. B-1 assumes a position on the dribbler so the front of his/her body is toward the dribbler. B-1 then turns sideways while in a retreating movement. A-1 charges into the shoulder of B-1. Official rules a blocking foul on B-1. Is the official correct? |

Official awards A-2 two free throws and the ball and rules the throw-in is a designated spot throw-in. Is the official correct? |

B-2, who has been guarding A-2 immediately switches so as to guard A-1. As the result, A-1 is continually closely guarded. While A-1 was being guarded by B-1, there had been a 2 second count. Three additional seconds are counted after B-2 switched to A-1. Official rules this a 5 second closely guarded violation. Is the official correct? |

A-2 rebounds the ball and the ball is slapped out of bounds by B-3. It is now discovered that A-1 was entitled to another free throw. Official awards A-1 the free throw and resumes play at the point of interruption. Is the official correct? |
