



25. Yes No 25. Official notices that A-1 is bleeding and directs A-1 to the bench to be replaced. Team A takes a time-out. Following the time-out, A-1 enters the court ready to play. Official denies A-1 from entering the court to participate. Is the official correct?
26. Yes No 26. A-1 is fouled as time expires in the first quarter. Prior to attempting the free throws, team B is assessed a technical foul. The official rules the second quarter will begin by administering the free throws for the technical foul. Is the official correct?
