| <ol style="list-style-type: none"> 1. Jumper A-1 taps the ball which is simultaneously deflected out of bounds by A-2 and B-2. The official rules a jump ball shall take place between any two players. Is the official correct? 2. A-1 is fouled and cannot attempt his/her free throws. The official rules that the opposing coach shall select one of the four players on the court to attempt the free throws. Is the official correct? 3. During A-1’s interrupted dribble, A-2 commits a common foul on B-2. Team B is in the bonus. The official rules this is a team control foul. Is the official correct? 4. Following a score by Team B, A-1’s throw-in pass is deflected out of bounds over the end line by B-1. The official awards the ball back to Team A and rules Team A may move along the end line. Is the official correct? 5. A-1 passes to A-2, who catches the ball while airborne. A-2 lands on his/her left foot. Then A-2 jumps off that foot and lands on his/her right foot. Before the left foot returns to the floor, A-2 tries for goal. The official rules it a traveling violation. Is the official correct? 6. Following a score by team B and while A-1 has the ball at his/her disposal, B-2 commits a common foul on A-2 near the endline. Team A is not in the bonus. The official awards the ball back to team A and rules team A may move along the end line. Is the official correct? 7. Prior to either team gaining control on a jump ball to start the extra period, A-2 fouls B-2. Team B is in the bonus. The official awards B-2 a one and one and has the scorer set the possession arrow when he/she places the ball at the disposal of B-2 for the first free throw. Is the official correct? 8. Following a successful free throw by A-1, the ball is lying on the floor directly under the basket. B-1 is out of bounds near the ball but makes no attempt to get the ball. The official pauses for a moment then starts the 5 second count. Is the official correct? 9. B-1 is bleeding and the official stops the game and directs B-1 to the bench. As B-1 is being attended to, the coach of team B requests and is granted a time-out. Following the time-out, B-1 comes back onto the court ready to play. The official allows B-1 to remain in the game. Is the official correct? 10. A-1 is erroneously awarded the ball out of bounds instead of receiving a one and one. Team A’s throw-in is intercepted by B-1 but he/she fumbles the ball back to A-2. It is now recognized that Team A was in the bonus. The official awards A-1 the one and one with players occupying the marked lane spaces and play will resume as with any normal free throw. Is the official correct? 11. While A-1’s first of two free throws is in flight, a double personal foul is assessed. The free throw is unsuccessful. The official awards A-1 his/her second free throw with players occupying the marked lane spaces and play resumes with the make or miss. Is the official correct? 12. During an alternating possession throw-in, the official awards the ball to team A by mistake. Team A commits a throw-in violation. The official awards the ball to team B and rules team B retains the arrow. Is the official correct? 13. While A-1’s free throw is in flight, B-1, in a marked lane space, commits a lane violation, followed by A-2 stepping into the lane. A-1’s try is unsuccessful. The official penalizes only B-1 and awards A-1 a substitute free throw. Is the official correct? 14. Number 55 is designated as a starter. As the teams enter the court to start the game, the scorer recognizes that number 25 is on the floor instead of #55. The scorer notifies the official. The official informs the coach that if #55 replaces #25 no penalty will be assessed. Is the official correct? 15. Defensive player B-2 leaps from his/her frontcourt and intercepts a pass from A-1 and lands on one foot in the frontcourt, jumps from that foot and comes to the floor in a stride jump stop with both feet landing simultaneously in his/her backcourt. The official rules this is a backcourt violation. Is the official correct? 16. Prior to A-1 releasing the ball on his/her first free throw, B-1 steps into the lane. The administering official inadvertently sounds the whistle. The official re-administers the free throw which is unsuccessful. The official awards A-1 a substitute free throw. Is the official correct? 17. As the referee is inspecting the equipment, he/she notices that a LED light is present on each backboard. The referee rules that the LED light is the official expiration of playing time. Is the referee correct? 18. A-1 has the ball for a throw-in following field goal when B-1 breaks the plane of the boundary line. 19. Yes No 19. Team A is running a weave offensive. A-1 dribbles towards A-2. As A-1 gets near A-2, A-1 completes the dribble and tosses the ball to A-2 as he/she runs by A-1. A-2 does not touch the ball. As the ball is bouncing on the floor, A-1 is the first to touch the ball. The official rules it a double dribble. Is the official correct?
20. Yes No 20. During an alternating possession throw-in by Team A, B-1 fouls A-2. Team A is not in the bonus. The official awards the ball back to Team A then instructs the scorer to turn the possession arrow toward Team B's basket when the ball is touched inbounds or out of bounds. Is the official correct?
21. Yes No 21. Following a score and with the ball at the disposal of A-1 for a throw-in, B-1 is charged with an intentional personal foul near the end line. After the free throws, the official awards the ball back to team A on the end line and rules team A has the privilege of moving along the end line. Is the official correct?
22. Yes No 22. A-1's throw-in is touched by B-1, who has one foot touching the boundary line. The official rules it a throw-in violation and awards team B the ball at the spot of throw-in. Is the official correct?
23. Yes No 23. After the official hands the ball to A-1 for a throw-in, a double personal foul is charged. The official uses the alternating possession procedure to resume play because neither team is in control. Is the official correct?
24. Yes No 24. B-1 commits his/her fifth foul and A-1 is awarded two free throws. As B-1's replacement is beckoned into the game, A-6 and A-7 report to enter the game. The official denies the substitutes from entering the game until A-1's final free throw. Is the official correct?
25. Yes No 25. A-1 is fouled as time expires in the third quarter. Team A is in the bonus. Prior to attempting the free throws, a technical foul is charged to the team B coach. The official administers A-1's free throws and starts the 4th quarter shooting the free throws for the technical foul. Is the official correct?
26. Yes No 26. Both A-1 and B-1 are bleeding and the official stops play and directs them to the bench. The coach of team A requests a time-out to keep A-1 in the game, while team B elects to substitute for B-1. The official grants Team A the time-out before the coach of Team B replaces B-1. Is the official correct?
27. Yes No 27. B-2 commits his/her fifth foul and A-1 is awarded two free throws. As the official is notifying the coach, the lead official administers the first free throw. The free throw is successful. The administering official now recognizes that his/her partner is still at the table. The official cancels the free throw and re-administers the free throw. Is the official correct?
28. Yes No 28. A-2, while standing in the backcourt, bats A-1's throw-in into the frontcourt where it hits A-3 and rebounds into the backcourt. A-2 is the first to touch the ball. The official rules it a backcourt violation. Is the ruling correct?
29. Yes No 29. Thrower-in A-1 loses his/her balance and in an effort to regain his/her balance touches B-1, who is inbounds. The official sounds the whistle and rules this a violation. Is the official correct?
30. Yes No 30. While the ball is at the disposal of A-1 for a free throw, A-2 commits a common foul on B-2. Team B is in the bonus. Following A-1's free throw the official awards B-2 a one and one. Is the official correct?
31. Yes No 31. A-1's throw-in is touched inbounds but not controlled. While the ball is loose, A-2 commits a common foul on B-1. The official rules it a team control foul. Is the official correct?
32. Yes No 32. During an interrupted dribble by A-1, A-1 inadvertently steps on the boundary line. When A-1 catches up to the ball and touches the ball to continue the dribble, the official sounds the whistle and rules it a violation. Is the official correct?
33. Yes No 33. A-1 enters the game with a red headband and a white sweatband. Team A's school colors are red and white. The official rules the headband and the sweatband are legal. Is the official correct?
34. Yes No 34. Team A is granted a time-out prior to team A's throw-in. Following the time-out, team A fails to have players return to the court at approximately the same time. The official pauses and then resumes play with the resumption of play procedure. Is the official correct?
35. Yes No 35. While A-1 is dribbling, the ball hits B-1's foot and bounces away from A-1. A-1 recovers the ball by catching it and starts a new dribble. The official rules this a double dribble. Is the official correct?
36. Yes No 36. A-1, while airborne, catches a pass then drops the ball to the floor. A-1 returns to the floor, gains possession of the ball and starts a dribble. The official rules it a legal play. Is the official correct?
37. Yes No 37. A-1, in the frontcourt, passes toward A-2. The ball is deflected by B-1 and is rolling on the floor toward the division line. A-2, who is straddling the division line, catches the ball. The official rules it a backcourt violation. Is the official correct?
38. Yes No 38. A-1's throw-in is caught by A-2 with one foot on the floor in frontcourt. A-2 then places the other foot down in the backcourt. The official rules it a legal play. Is the official correct?
39. Yes No 39. A-1 fouls B-1 while A-2 is in the act of shooting and before releasing the ball. A-2 continues the throwing motion and the try is successful. The official penalizes the foul and counts the basket. Is the official correct?

| 48. A-1, while attempting to rebound, loses his balance and grasps the ring, pulling it down. After releasing his/her hand from the ring and before the ring returns to its original position the ring contacts the ball. The official rules this basket interference. Is the official correct? | 48. | Yes | No |
| 49. With 3 tenths of a second on the game clock, play is resumed with a throw-in by A-1. A-1's throw-in is caught by A-2, who tries for a goal. Prior to the horn sounding, B-1 fouls A-2. A-2 releases the ball and time expires. The ball fails to enter the basket. The official awards A-2 two free throws for being fouled in the act of shooting. Is the official correct? | 49. | Yes | No |
| 50. While A-1 is dribbling near an opponent, the ball touches an opponent but there is no loss of control by A-1. A-1 immediately catches the ball and starts another dribble. The official rules it a double dribble. Is the official correct? | 50. | Yes | No |
| 51. Team A scores and is granted a time-out with 3 seconds on the clock. Following the time-out, B-1 passes the ball to B-2 on the end line. When B-2 catches the ball, the timer mistakenly starts the clock. While B-2's pass is in flight toward B-3, the official recognizes the clock is running. The official sounds the whistle, instructs the timer to put the consumed time back on the clock and resumes play by awarding the ball back to team B at the spot of the throw-in. | 53. While team A players are taking the floor to start the game, the official notices that team A's jerseys have a school mascot located on the back of the jersey in the apex of the neckline. The official rules that the jerseys are illegal. Is the official correct? | 53. | Yes | No |
| 54. During the 1st quarter, A-3 sets a screen in the middle of the free throw lane. A-1 cuts off the screen, receives a pass near the edge of the lane and jumps to attempt a short bank shot. While in the air and before A-1 releases the ball, B-1 is whistled for a foul for pushing through the screen. The ball goes through the basket. Team A is not in the bonus. The officials cancels the basket and awards the ball out of bounds on the endline to Team A. Is the official correct? | 54. | Yes | No |

| 56. A-1 is fouled in the act of shooting. While A-1's try is in flight, the horn sounds indicating time has expired in the game. The try enters the basket to tie the score. Prior to A-1's free throw team B is granted a time-out. Following the time-out A-1's free throw attempt is unsuccessful. As the horn sounds to start the extra period, the coach of team A senses his/her team is tired and requests a time-out. The official grants the request. Is the official correct? | 56. | Yes | No |
| 57. A-6 substitutes for A-1. Before the clock starts, A-2 commits his/her fifth foul. The only team member on Team A's bench is A-1. The official rules A-1 may not reenter until the next opportunity to substitute. Is the official correct? | 57. | Yes | No |
| 58. While A-1's free throw for a one and one is in flight, A-2 and B-2 commit a double personal foul, followed by A-1 committing a free throw violation. The possession arrow favors team A. The official resumes play by awarding the ball to team B. Is the official correct? | 58. | Yes | No |

59. Yes No 59. A-1, who is airborne and going to attempt a try, has the ball batted from his/her hand from behind by B-1. A-1 prior to returning to the floor charges B-2. The official rules a player control foul, stating A-1 was an airborne shooter. Is the official correct?
60. Yes No 60. As A-1 starts the motion to attempt a free throw. B-2, in a marked lane space, raises his/her arms in a quick motion. A-1 after releasing the ball commits a violation. The try is successful. The official rules the action by B-2 as disconcerting, cancels A-1's free throw and awards A-1 a substitute free throw. Is the official correct?
61. Yes No 61. A-2, while occupying a marked lane space, takes a position two feet from the outer edge of the free throw lane line. The official informs A-2 he/she must position one foot near the lane line. Is the official correct?
62. Yes No 62. At the start of the third quarter, Team A takes an excessive time-out. The scorer fails to notify the official. After the third quarter has ended, the scorer informs the official that Team A's last time-out was an excessive time-out. The official rules that to penalize an excessive time-out it had to be recognized within the correctable error time frame. Is the official correct?
63. Yes No 63. While A-1's pass is in flight toward A-2, a double personal foul is committed. The official awards the ball back to Team A nearest the spot where the ball was last in contact with A-1. Is the official correct?
64. Yes No 64. With 9 seconds on the game clock, B-1 commits basket interference on A-1's free throw. The timer started the game clock when B-1 touched the ball. The official instructs the timer to put the consumed time back on the game clock. Is the official correct?

During A-1's free throw, and before the ball contacts the backboard or ring or the free throw ends, A-2 in a marked lane space, loses his/her balance and makes contact with his/her hand in the lane. The official rules making contact with any part of the court outside a marked lane space is a violation. Is the official correct?
67. Yes No 67. Team A scores and prior to the ball being at the disposal of Team B, a double technical foul is committed. The possession arrow favors Team A. The official awards the ball to team B for the throw-in and rules Team B may move along the end line. Is the official correct?
68. Yes No 68. The arrow favors team B but by mistake the official awards the ball to team A. Before the ball is touched inbounds, team A is charged with a technical foul. The official rules the alternating possession throw-in did not end and team B will have the next throw-in under the alternating possession procedure. Is the official correct?
69. Yes No 69. A-1 receives a head injury in the first quarter and shows signs of a concussion. The referee directs A-1 to the bench. As the third quarter is about to start, the official notices that A-1 is on the floor. The referee informs the Health Care Professional that A-1 may not return to play in this game without written authorization from him/her or a physician. (MD/DO) Is the referee correct?
70. Yes No 70. Team A is granted a time-out. As the teams are going to their benches, A-1 is assessed a technical foul. The official charges Team A coach with an indirect technical foul ruling that during a time-out, players are bench personnel. Is the official correct?
71. Yes No 71. The official erroneously states a one and one instead of two shots. A-1 misses the first free throw which is rebounded by B-1. As B-1 is dribbling up court, B-3 is charged with a common foul against A-3. Team A is in the bonus. The error is now recognized. The official awards A-1 his/her second free throw with the lane cleared, then awards A-3 a one and one and plays off the make or miss. Is the official correct?
72. Yes No 72. B-1 commits a common foul which is his/her fifth foul. Team A is not in the bonus. Following the warning horn, B-6 replaces B-1. As B-6 is beckoned into the game, A-6 reports to enter the game. The official denies A-6 from entering the court. Is the official correct?
73. Yes No 73. A-1, in the frontcourt, is dribbling near the division line. As A-1 pushes the dribble to the floor, the ball touches the division line. As the ball bounces up from the floor and touches A-1, the official rules a backcourt violation. Is the official correct?
74. Yes No 74. Team B scores to take the lead by one point. Team A immediately is granted a time-out with 3 seconds remaining in the game. Following the time-out, team A is awarded the ball for a throw-in. A-1 passes the ball to A-2, who is out of bounds on the end line. A-2 passes the ball to A-3 at mid-court. A-3 catches the ball. The timer mistakenly started the game clock when A-2 caught the ball while standing out of bounds. The official notices the clock is running and sounds the whistle just after A-3 catches the ball. The official has the timer put the consumed time back on the clock and resumes play nearest to where the ball was located when stoppage occurred. Is the official correct?
75. Yes No 75. Following a lengthy substitution involving multiple substitutes for both teams, A-5 believes he/she has been replaced. While play is in process, the team A coach realizes he/she has only 4 players on the court. The coach yells for A-5 to get into the game. A-5 enters the court and in so doing does not provide team A with an advantage. The official stops play and charges team A with a technical foul. Is the official correct?
